I, on behalf of myself and/or my children (if a child is identified above), hereby acknowledge that THE SAL SWIMMING & DIVING CHAMPIONSHIP MEET is inherently dangerous and that my/our participation in THE SAL SWIMMING & DIVING CHAMPIONSHIP MEET could cause me and/or my children great bodily harm. I, on behalf of myself and/or my children (if a child is identified above), hereby assume the risk of my/our participation in THE SAL SWIMMING & DIVING CHAMPIONSHIP MEET. I, on behalf of myself and/or my children (if a child is identified above), further certify that I/we assume the risk of any pre-existing physical or medical condition I/we may have.

If the children listed above are under 18 ("Child"), the Adult signing above and below ("Adult") represents that he/she is the parent or legal guardian of the Child and that Adult is signing above and below on behalf of the Child. No Child will be allowed access to THE LASALLE UNIVERSITY KIRK POOL COMPLEX or to participate in THE SAL SWIMMING & DIVING CHAMPIONSHIP MEET without an Agreement fully signed by his/her parent or legal guardian. Any misrepresentation by Adult will be prosecuted to the fullest extent of the law, including (but not limited to) under any applicable fraud and/or trespassing statutes/laws.

In signing this Agreement, I, on behalf of myself and/or my children (if a child is identified above), surrender any right I/we may have or may later accrue to recover, through a court of law or by other means, compensation for any personal injuries, including bodily injury or even death, or property damage, based upon, arising out of, logically or causally related to, or in any way involving my/our participation in THE SAL SWIMMING & DIVING CHAMPIONSHIP MEET and/or my/our presence at THE LASALLE UNIVERSITY KIRK POOL COMPLEX. In consideration for THE SUBURBAN AQUATIC LEAGUE and LASALLE UNIVERSITY allowing me/us to enter THE LASALLE UNIVERSITY KIRK POOL COMPLEX and to participate in THE SAL SWIMMING & DIVING CHAMPIONSHIP MEET, I, on behalf of myself and/or my children (if a child is identified above), agree to release THE SUBURBAN AQUATIC LEAGUE AND LASALLE UNIVERSITY and any of its officers, directors, employees, agents, affiliates, successors, members, insurers, attorneys and assigns (the "Released Parties") from any and all claims, whether known or unknown, in law or in equity, in contract, in tort, or under common law, or under any state or federal statute or otherwise.

I, on behalf of myself and/or my children (if a child is identified above), certify that I/we have adequate insurance to cover any personal injuries, including bodily injury or even death, or property damage that I/we may incur based upon, arising out of, logically or causally related to, or in any way involving my and/or my children's participation in THE SAL SWIMMING & DIVING CHAMPIONSHIP MEET and/or my and/or my child's presence at THE LASALLE UNIVERSITY KIRK POOL COMPLEX.

I, on behalf of myself and/or my children (if a child is identified above), agree to defend, indemnify, and hold harmless the Released Parties from any losses, liability, damages and costs, including (but not limited to) all attorneys' fees and court costs, based upon, arising out of, logically or causally related to, or in any way involving my/our participation in THE SAL SWIMMING & DIVING CHAMPIONSHIP MEET and/or my/our presence at THE LASALLE UNIVERSITY KIRK POOL COMPLEX.

If there are any disputes regarding the Agreement, I, on behalf of myself and/or my children (if a child is identified above), agree that such dispute shall be brought within one year of the date of this Agreement and will be determined by arbitration before one arbitrator to be administered by JAMS pursuant to its Comprehensive Arbitration Rules and Procedures. I, on behalf of myself and/or my children (if a child is identified above), agree that, if any portion of this Agreement is deemed unenforceable, the remaining portions shall remain in full force.

I, on behalf of myself and/or my children (if a child is identified above), acknowledge that I/we have read and understand the rules provided to me with this Agreement. I/we agree to FOLLOW ALL OF THESE RULES. My/our failure to follow these rules could lead to harm to myself/us and others. If I/we fail to follow the rules, I/we will be subject to expulsion from THE LASALLE UNIVERSITY KIRK POOL COMPLEX.
