10. New Business

- a. team database control is important when submitting information to the league. Reminder to the teams, watch how athletes are registered. Also, gather middle initial for all athletes so that database is cleaner. Mid-Atlantic needs at least three weeks to get an athlete on the books. Double check USA Swimming designations. Match to the SWIMS database.
- b. Coaches report Brian Zeigler Perk Valley. One issue invitationals. Why are parents from other teams REQUIRED to work at invitations? And why won't they start the meet without the volunteers? This applies to swim invitationals not diving. The league will NOT mandate how teams run their own invitational meets. Possible tie the number of volunteers to the number of entries. Second issue 18 out of the 22 teams have a USA team. Coaches' dilemma USA Elite meet vs. league championship meet. Is it fair to make the athlete choose? Schedule may not avoid the Elite meet because SAL leagues are based on availability of LaSalle. Should we consider high school conflicting meets as well?
- c. Diving scoring for electronics. Will be meeting to discuss further. Methacton liked it. Not going to be league mandated to purchase diving software for the 2013-2014 season. There will be email announcements for diving meetings by the league. Make sure to update your league directory with the SAL website.
