Please double check all usa ID numbers, only submit athletes who are rostered for this season.

Please reach out to SAL registrars if you have any questions! There may be possible fines if not done correctly!

Swimmers must have swim 40% of dual meets (at least 2 meets) to be eligible.

Relays must be actual swum times only from top 40, make sure your B relay is accurate too

Psych sheets will be updated sometime on Tuesday the 15th
