## Schedule:

Please be sure to print out the updated League Schedule from the website. Changes were made as late as the swim coach's meeting...

## Insurance Accords:

Always due prior to Fall Reps meeting. If set to expire during the season, please send in the old one initially and the updated replacement a few days before it will expire.

## Code of Conduct Affidavit:

All three reps, two if your team does not have diving, should review the required documents, sign the affidavit and bring the signed copy to the fall rep meeting.

<u>Letters of Intent for Invitationals</u> – If your invitational information (flyer and TM events file) is not on league site get it to the League webmaster ASAP. Your letter of intent is due at the fall meeting for League approval of the schedule.

#### Team Directories:

As your team makes changes to their board members/coaching staff please send an updated directory to the Chair and the Webmaster. Do not send changes in the body of an email... we only REPLACE the file on the website. We do not type individual information into the list.

New USAS ID's, etc. We will review ID's and Champs at the Winter meetings. Make sure you have current copies of USAS and USAD rules on deck. Please keep in mind that while we follow most of their rules, we do have a few things that the SAL does differently...

Review ALL SAL docs: OPS, By-Laws, Mandated Reporter, Code of Conduct, website documents, etc.... Your team is responsible to follow any unusual circumstances and procedures discussed at the meetings and refamiliarize yourselves with the Operating Procedures every season.

## Schedule "match-up" changes:

Swimming and diving will compete separately (similar to last season/just for this season as we hope to return to normal next season)

# <u>Dive:</u>

Will only split into two divisions for our Division Championship Meet. Otherwise, the teams that have diving will compete over the entirety of the season. In other words, seven dual meets. Scores will not count for swim purposes this season. However, remember that when it comes to OFFICIAL events diving counts as an event.

If issues arise and teams need assistance – first go to division reps => then appropriate president => then league chair This is a winter sport – there will be weather issues – be understanding – most teams compete in school buildings so, do not have control over open/closed – be considerate and work together if weather impacts a meet

The website is updated daily at this time of year. **Updated meet templates will be up next week.** If you are looking for something or see something needs updating, please reach out to our Webmaster.

We need a Girl's Champs Chair. If you know of someone who is good with TM and MM, please have them reach out. We will NOT HAVE a final League Girl's Championship Meet without someone stepping up to help.

Weather and building issues- remember that there is a one-week rule for make-ups, no team may swim or dive alone, we must all work together for weather issues

## Registrars -

- Releases expectation of league is that if a release is requested the team receiving the request will respond within a couple of days even if not planning to release.
- Release emails to the registrars need to say the team releasing the athlete and the name of the
  athlete being released do not need to say which team is requesting the release. Please only
  send the final release email. We do not need to be involved in the going back and forth
  discussion leading up to a release. All it does is fill up our inboxes. Also, do not copy any other
  Board members on release emails.
- Teams should ask for prior year rosters from SAL registrars and double check new people to be sure you do not miss any releases.
- Information for submitting rosters is in the OP's:
  - o submit everything by due date on SAL schedule
  - submit additions whenever they occur
  - Initial roster due date: October 5<sup>th</sup>
  - Deadline to be rostered to participate in dual meet #1 and first invitational: October 19<sup>th</sup>
  - o NO ROSTER **FILES** AFTER 10/19... send info in body of email (see last bullet below)
  - o 10-day rule athlete must be rostered 10 days before meet participation
  - for additions and initial rosters
    - > send boys only TM file to boys' registrar (include male swimmers and divers)
    - > send girls only TM file to girls' registrar (include female swimmer and divers)
    - send divers only TM file to diving registrar (include female and male divers only) NO SWIMMERS WHO ARE NOT DIVERS
    - Carefully roster with name you will use every time nickname/middle initial etc.
    - Include USAS ID's if they are registered with USAS
    - ➤ Divers need D and division code— divers are registered as swimmers, but swimmers are not registered as divers. (Division group; diver sub-group) Even though we are competing separately this season be sure to use your normal division code

- person who sends diving roster will get list back if an athlete is not on that list
   - they are NOT registered contact diving registrar and ask for help if someone is missing (swim v dive rostered)
- When emailing additions, provide name, birth date, sex, team name and team code note if athlete is a swimmer or a diver. Info provided must be exactly as it is in your database (must be same everywhere be careful with nicknames and middle initials). Send to the appropriate registrars per the above.
- Submitting results:
  - o Submit swim results files on time per OPs/mail dive paperwork so that it arrives by deadline
  - o As previously stated, diving scores will not be included with swim results this season

<u>Official's clinics</u> — Mike is working with our new coordinator. An email will be sent out as soon as dates, times and locations are established. Information will be posted on the SAL website. SAL official's certification is on a two-year cycle: if you have a parent with a current PIAA, YMCA, and/or USAS certification submit their name to Mike and Tim. Those parents do not have to attend a clinic. **ANYONE WHO IS NOT CERTIFIED PER THE ABOVE WILL BE REQUIRED TO ATTEND ONE OF THIS SEASON'S CLINICS.** If you have an official on deck for a meet that does not meet the requirements above your team will forfeit everything associated with the hosting of the meet and no record breaks will be honored.

Diving volunteer training clinic – ALL NEW PARENTS MUST ATTEND ONE – will learn to judge and work table. Check the website for location and time updates. If you are interested in hosting one, please reach out to me asap.
